#### **4. Portfolio reports**

- a) President's report (*Farzad Sharifian*)

The President thanked the 2016 ALAA Conference Organizing Committee, in particular the Convenor Robyn Spence-Brown from Monash University. He then highlighted the Association's achievements over 2016.

- There has been a focus on membership
- A new international publisher, John Benjamins has taken on publication of ARAL. The editor hopes to widen the international profile of the editorial team
- The President has initiated contact across an Asia-Pacific network of Applied Linguistics associations.

President's report approved - Moved by Jonathan Crichton; Seconded by Howard Nicholas. Accepted.

b) Vice-President's report

Honglin formally awarded the four ALAA postgraduate travel scholarships and the M.A.K. Halliday Award. The recipients are:

Naoki Ikeda (M.A.K. Halliday Award)

Manh Duc Le; Ngoc TH Hoang; Nishioka Hiromi; Sally Chan (ALAA Travel scholarships)

It was suggested that the Penny McKay Memorial Award needs to be publicized earlier in 2017 as the turn around for applicants' submissions this year was too short.

It was noted that the Michael Clyne Prize is announced and awarded at the ALS AGM.

Vice-President's report approved - moved by Nina Rubino; seconded by Neomi Storch. Accepted.

c) ARAL Editor's report

Chris Davison spoke to her report which is attached to these minutes. She pointed out to issues 1-5.

ARAL Editor's report approved: Moved by Honglin Chen; seconded by Jonathan. Accepted.

d) Secretary's report and Treasurer's report

Colette did not table a Secretary's report. Colette presented the Treasurer's report on behalf of Michael Harrington. She spoke to the attached report. Any questions should be directed to Michael, with copy to members of the Executive.

Treasurer's report approved: Moved by Paul Moore and seconded by Farzad. Accepted.

a) Information Officer's report

Jonathan spoke of the difficulties encountered with the website and changes of website provider which has caused delays in uploading and updating materials.

It was suggested by Chris to create a Facebook page for ALAA members to exchange information and interact with each other. The website should remain to provide a stable platform, a repository of links and an archive of important documents.

Farzad thanked Jonathan for his efficiency and his tenacity in trying to resolve these issues. Nina also expressed her thanks.

Information Officer's report approved– Moved by Howard; seconded by Honglin. Accepted.

## 5. Proposed changes to ALAA membership fees

ARAL Editor Chris Davison spoke about ALAA current membership fees and ARAL publication costs. Chris reported that the ARAL subscription was 35 Euros (approximately \$50.24) in 2016. This means that all member categories except Individual attract negative margins under the current membership fee structure. There is an urgent need to raise membership fees to rectify the negative margins. Two motions were proposed to the membership.

Motion 1: That ALAA delete the Joint membership category from 2017 as it is not financially viable.

The motion was unanimously voted for. Motion carried.

Motion 2: That ALAA will increase its membership fees from 2017.

Three options were presented to the membership for voting. They are:

1. *Leave as is*
2. *Increase both Individual and Student membership fees to \$80 (Individual) and \$40 (Student) respectively.*
3. *Increase student membership fee to \$50 since it is the category that is identified as creating the deficit.*

There was debate about which option would be better for the Student category. For the sake of long term planning for the association, it was suggested that ALAA should adopt Option 2. This proposal was held by the majority of votes. It was agreed that ALAA will increase both Individual and Student membership fees to \$80 (Individual) and \$40 (Student). Motion was carried.

## 6. Elections of office bearers

Colette acted as a returning officer. Nominations for the following positions were received:

Since two nominations were received for the position of Vice-President, a vote was conducted online via Wordpress. There were 40 respondents. The results were 67.5% in favour of Jonathan Crichton and 32.5% for Shen Chen. All nominees were accepted for the other positions.

**Treasurer's Report**  
**ALAA AGM 2016 Melbourne**

**1. Overview**

- The overall budget position at the end of the 2015/16 FY is down slightly from the previous year but overall remains very healthy. The operating account had a deficit compared to the previous year, mostly due to the establishment of a new membership account which receives membership payments. The FY end total was also affected by the fact that no conference float surplus was returned from ALAA Adelaide 2015.
- The operating and membership accounts have a combined balance of \$70,000. A portion of this could be earning higher interest in the term deposit.
- It would be timely to undertake a more general review of ALAA financial arrangements and processes. With the establishment of a separate membership account income we now receive income into both the membership account, in the form of membership fees, and the operating account in the form of copyright fees and conference float surpluses. Expenses have hitherto been paid out of the operating account. How the new arrangements with ARAL and John Benjamins affect this arrangement this needs to be clarified. This is also related to rises in membership fees, which is being discussed as a separate agenda item.

**2. Account balances**

The balances for the ALAA accounts at 31 July 2016 are presented in Table 1.

## 5. Conference support

1. ALAA Adelaide 2015 conference was floated \$5000 on 3/12/14). There has yet to be a return of the float and any surplus.
2. There was no conference float requested for ALAA Melbourne 2016.

## 6. Other

1. Copyright income was \$4193, compared to \$6066 in 2015 and \$1246 in 2014.
2. AILA membership was renewed on the basis of 135 members comprised of 102 regular and 33 students memberships. Previous numbers: 165 (2015); 86 (2014), 96 (2013) 130 (2012) and 193 (2011) paid-up members. The 2012 and 2011 numbers may have been inflated. Membership is now handled through ARAL and a separate membership account.
3. The 2014-2015 and 2015-2106 audits are being prepared by Walker Wayland.
4. An award of \$500 from the Penny Mackay Fund was made to Dr Jennifer Alford.

## 7. Items for consideration and action

1. In January 2015 the ALAA accounts were switched over to NAB Connect to facilitate on-line transactions. A separate dedicated membership account has also been established to facilitate payments. Currently all payments are authorised solely by the Treasurer. Although this is a very convenient arrangement, the potential for abuse is always there. When the new officers take over the Executive might consider giving two Executive members authorisation to approve payments in addition to the Treasurer, and require all payments to be approved by both the treasurer and one of the



authorised members. Given the small number of annual transactions this should not be too demanding.

2. Now is also a good time to undertake more general review of ALAA financial arrangements and processes. With the establishment of a separate membership account income is now received in both the membership account in the form of membership fees, and the operating account in form of copyright fees and conference float surpluses. Expenses have hitherto been paid out of the operating account. How the new arrangements with John Benjamins impacts this needs to be clarified. This is also related to rises in membership fees, which is being discussed as a separate agenda item.

SJR is a measure of scientific influence of journals that accounts for both the number of citations received by a journal and the importance or prestige of the journals where such citations come from. It measures the scientific influence of the average article in a journal, it expresses how central to the global scientific discussion an average article of the journal is.**

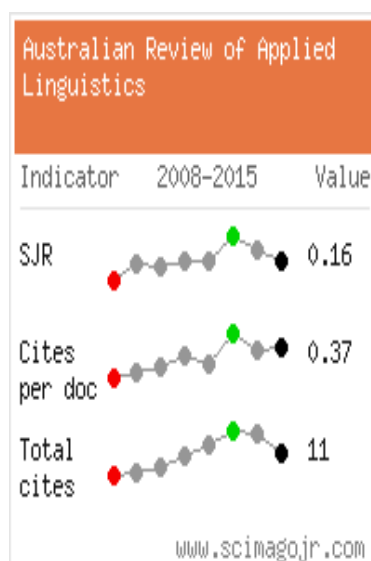
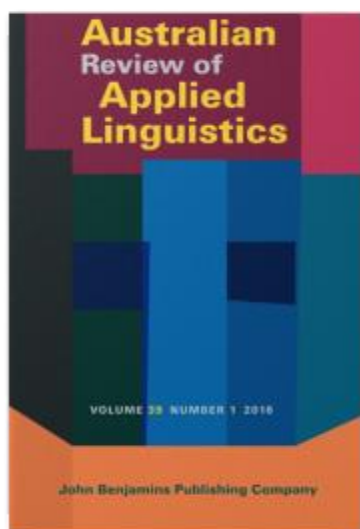
